Keynote Speaker

Dr Kazi Sohag is an Associate Professor at the Graduate School of Management, Saint Petersburg University, Russian Federation. Kazi Sohag is also head of the Laboratory for Natural Resrouce Policy under Ural Federal University. He was an adjunct research fellow at the School of Commerce, University of Southern Queensland, Australia. Dr Kazi is also an associate research fellow at the Accounting Research Institute, UiTM, Malaysia. He is an External Researcher at the Center of Research Excellence in Renewable Energy and Power Systems, King Abdulaziz University, Jeddah, Saudi Arabia. Dr Kazi is a contributing author of IPCC Working Group III under UNFCCC. He has been appointed by the University of Merdeka, Malang, as a Visiting professor under the World Class Professor Program (WCP) 2021 by the Ministry of Education, Culture, Research and Technology, Indonesia. He obtained a PhD in Environmental Economics from the National University of Malaysia in 2017.

Kazi Sohag received a diploma in Global VAR Modeling using the GVAR from the Czech University of Life Sciences, Czech Republic 2019, and Energy and Environmental CGE Modeling with GAMS from EcoMod, Singapore, in 2015. According to RePEc, Kazi Sohag is among the top 1000 economists in the world. He is also the top second economist in Russia (based on the last ten year's publications). According to Stanford University's evaluation, Kazi also appears in the top 2% of influential researchers. Kazi Sohag is a regular reviewer of more than 50 high-impact journals. His H-index is 41, where the total citation is more than 8400. He delivered numerous public lectures and keynote speeches around the globe. Dr Kazi has been awarded several international research grants from different countries, including Russia, Iran, Malaysia, Kosovo, UAE, Indonesia, and KSA.



Special Guest

Professor Kayhan Tajeddini currently serves as part-time Professor of Hospitality Strategic Management at Sheffield Hallam University (UK, since 2018) and part-time Professor of Strategic Management and International Business at Tokyo International University. His distinguished academic career includes positions as Docent and Associate Professor at Lund University (Sweden), Associate Professor at Asia Pacific University (Japan), and Lecturer at Les Roches School of Management (Switzerland) and University of South Wales (UK), following his start as a Research Assistant at Bradford University (UK).

His scholarly work spans strategic management, hospitality, and international business, appearing in over 100 refereed publications across high-impact venues.

As Chief Editor of the Interdisciplinary Journal of Management Studies and Middle East Journal of Management, and Deputy Editor of Annals of Leisure Research, Professor Tajeddini provides editorial leadership to the academic community.

He serves on the editorial boards of prestigious journals such as:
